



## **Minutes of Joint BOD Meeting**

June 19, 2007 - 7:00 at the home of Norm and Ibby Ulmer

Members Present: Nick Buchholz, Norm Ulmer, Jay Sanders, Rick Gast, Jim Miller, Jim Cook, Willis Fagg, Lew Sleeper and Ibby Ulmer, acting Secretery.

The minutes of the last meeting were approved as printed in the Newsletter.

**Treasurer's Report:** Willis Fagg reported the following:

- 1. Current checking account balance is \$5,931.39
- 2. Reserve account balance is \$3,012.06 for a total of \$8,943.45
- 3. Revenues to date for fiscal year 2006-2007 are \$9,593.85 and expenses are \$12,712.07 for a net decrease to date of \$3,118.22
- 4. Membership renewals appear to be running a little behind normal this year at \$1290.00. This represents 49 members have paid for the new year.

Rick Gast moved and it was seconded and passed that the Treasurer transfer \$900.00 from the checking account to the reserve account.

**Events:** Lew Sleeper reporting

- The SAHBA Home Show in October is being explored. The location that SAHBA wants to give us is questionable since it is under the bleachers in the ice rink and is dark and lacking of electrical facilities. This must be explored before we can make a definite commitment.
- 2. Reid park was discussed briefly, and rejected.
- 3. Colossal Cave Pioneer Days is the same time as the SAHBA home show and therefore is out.
- 4. American Home Show in January
- 5. There will be a Swap Meet on December 8th. This may conflict with something else. There will be another Swap Meet in January.
- 6. St Mark's Methodist Church December 9
- 7. Botanical Gardens Gary Martin will coordinate.

- 8. VA Hospital will be the week between Christmas and New Years.
- 9. University Medical Center. Norm Ulmer and Chuck Cook met with the people at the new Cancer Care Center and saw the place the railroad would be put in. There was a question of putting in a new access door to the area. Norm has gotten two quotes for the new door and gave those to UMC. The ball is in their court.
- 10. Pima County Fair. They had been told that we cannot have a layout there in 2008 due to the Convention, but had sent a letter to Willis as if they are expecting us. Willis will send them a letter making it clear that we are not able to be there.

#### **Old Business**

A. Convention Report - Norm Ulmer

B. Non-Profit Status. Jay Sanders presented an analysis from his tax consultant which indicated that as a 501C(7) we may have accumulated a tax liability of approximately \$5000.00. However as a 501C(4) we do not have a tax liability. After much discussion concerning the application for 501C(3) it looks like, upon filing the application we have the option of selecting the status of a 501C(4) commencing with the original date of our incorporation.

C. In order to file an application for 501C(3) status we must first do several things:

- We must file a copy of our amended and restated Articles of Incorporation. This will be done tomorrow right after Norm Ulmer, Ellen Stoesser and Willis Fagg have their signatures on the Articles notarized. Jay expects this will be approved by the Arizona Corporation Commission before the 28th of July.
- 2. We must revise our By-Laws to reflect the inclusion of anti-discrimination and dissolution clauses. Jay Sanders will provide Norm Ulmer with the required language for these revisions and Norm will post them by email to the Society members. There will be a special general membership meeting at 10:00 A.M. on July 28th at Nick Buchholz house in order to vote on these revisions.
- 3. Nick Buchholz will complete the 1023 {501C(3) application} by the time of the special meeting.
- 4. Assuming all of this is accomplished by the end of July, we will file the application together with a copy of our State approved restated Articles of Incorporation and our revised By-Laws. This will require a filing fee of \$750.00. Willis moved and it was seconded that we approve the expenditure for the filing fee. Motion passed.

#### **New Business**

A. A new town design was put on hold because it was not requested by the Convention Committee.

B. New infra-structure purchases (Work lamp, bench stool and torque screwdriver, etc.) were approved.

- C. There was discussion of the re-building of the over the track stairs to lower the step height. And to re-work the lift bridge.
- D. Membership Chairman, Ibby Ulmer, presented a revised version of the Membership Application folder. A few suggestions were made and will be incorporated.
- E. There was also a discussion of re-wiring the medium size trailer and putting swivel casters on all racks.

#### **Announcements**

Norm Ulmer announced that he would like suggestions for new Education and Mentor chairmen. He will add an additional committee for Maintenance and Gary Martin has agreed to serve as Chairman. He also asked for ideas to encourage more membership participation in the Society's activities.

The meeting was adjourned.
