Driving Directions

From I-19 take the Ajo Exit and proceed west on Ajo Way to Mission Rd. Turn left onto Mission Rd. and proceed approximately 1/2 mile to a left turnout (2nd turnout on Mission Rd.). Turn left here at white entrance wall marked 4545 and flag flying. Go 500 ft. and turn right into RCW Resort. Stop at gate keeper building and indicate you are attending TGRS meeting. Proceed straight down the boulevard to large parking lot on the left. There is parking all around the buildings in this area. The RCW Railroad layout is located at the end of the parking lot.

Rincon Country West Railroad

The RCW RR and layout is the ongoing project of the RCW Garden Railroad Club located at the Rincon Country West RV Resort. The club has been developing its layout over the past three winters as most of our members are "snowbirds". We have over 300 ft. of track with three independent loops. Each loop has track power. Our village of Rincon is composed of lighted scratch built structures named for existing clubs in the RCW Park(Shuffles Boarding House, Tennis Court House, etc.). Our extensive vegetation is maintained by club members and has its own irrigation system. We are presently in the process of completing, at the layout, the RCW Depot

which will serve as our storage shed. Future expansion of the layout is in the planning phase.

Minutes of the January BOD Meeting

All Board members were present except 2 Pres. Norm thanked lbby for hosting Minutes of the November meeting were approved.

Treasurer's Report: Norm reported for Willis Fagg:

- 1. Current checking account balance is \$3,009.72.
- 2. Reserve account balance is \$3,918.82 for a total of all accounts of \$6,928.54.
- 3. Revenues to date are \$2,226.50 and expenses of \$3,718.23 for a net decrease of \$1,492.23.
- 4. Membership renewal total is 87.
- 5. The Treasurer's Report was approved.

Vice President Events: Lew Sleeper reported that the basic modules would be used at the swap meet Saturday. We will be selling RITG tickets. The Home Show will be in June. June 6,7, & 8.

Membership Chairman's Report: Ibby Ulmer reported we have 87 members.

Mentor Committee: Nick Buchholz reported he has 3 mentors assigned to the 3 members requesting them. He will need counselors for the Scout Merit Badge program.

Social Committee: Norm reported there were 18-20 people at our first social gathering. There was "good food with good company". The price of the meal was \$9:00, all you could eat. We will hold one more at R&R Express and the one after that will be at Fuddrucker's on the east side.

Old Business:

- A. Norm reported we are waiting on Split Jaw power clamps to complete the 2 ft Bridge approach modules.
- B. Convention report: Norm reported the hotel is 80% full and 471 people have registered so far. They are not buying the extra things. Volunteers are starting to sign up and some of the hours will be revised. We have 240 Bachmans donated and 30 USA and 3 reefers with lots of other prizes.
- C. **TBG:** Norm reported for Gary Martin that TBG will leave the track down and they are looking for donations of houses and cars. He will start working on bridges and needs a work detail for the track.
- D. **Day Chairman Duties.** Jim Cook had copies of the duties of a Day Chairman for the Board to look at and evaluate.

New Business: RITG: March 8 & 9, 2008 – Dirk would like some members to help on Thursday (1/17/08) with a mailing. We are selling tickets at Ace. Dirk has talked to Bonnie Henry about us. R&R Express will be putting flyers on their pizza boxes the month of February. Dirk will go to the Visitors Center a month before the event with flyers. Lee Willets is working on the monthlies. Accent is 3 weeks before the event. KNST is free on Friday morning, just call in; lbby will try to get on. The sites will be in this order---Blackwell---Martin---Dorgan---Stoesser---Sander---Gast--- Jim Cook---Karrel. These will be open from 10:00 to 4:00. Dirk will comp. tickets to Michelle at TBG and 2 teachers and 11 children from the Deaf and Blind School for the RITG weekend.

New Business:

Norm talked to 2 women who owned restaurants downtown and they invited the Board to lunch and to visit some of the empty storefronts to see if it would be possible to set up a Christmas display. Maybe this could be in conjunction with the Festival of Lights. Since all members are busy at this time we could set up early and take down at our leisure. There would be security. Since we are a 501 (c) 3, maybe someone would donate us a building. The Board will explore this idea.

Veterans Hospital: Norm reported that Pepe Mendoza would like us to explore the idea of doing an October Show.

Insurance: Willis was checking on changing our insurance company. Our present agent did not feel he was making enough money from our policy.

State Farm agent Tom Bower has suggested we switch to them. The old policy cost us app. \$900.00. Tom would give us, rolling stock and modules-\$17,000-18,000. Since they are in separate trailers and not likely to be damaged at the same time this is adequate. Better (\$2-4 million) coverage. \$330/A liability, +/-\$150 on trailers. This would be a saving of over \$300 a year. A motion was made by Norm that the Board approve a \$490 check and change insurance. This was approved by the Board. There will be a separate rider for the 2008 convention at the cost of \$25.00 for a month.

Data Base: Nick has received 8 sheets for the data base.

Birthday Parties: At the Home Show Dirk was asked if we were interested in doing birthday parties. **Schools**: Lew will compose a letter with our curriculum on a separate sheet asking the elementary schools if they would be interested in us doing a set up for them.

Children's Hospital: Jim Cook will contact the fundraisers of Children's Hospital, construction has started, to see about us being there. He will take DVD's of the hospitals that are in Phoenix to show him how it can be done. If we would do this, it would be a whimsical set up.

Loading the trailers: Do we need a loadmaster or rack master? Should we mark on the outside of the boxes where things go? Lew would like more work days to organize the trailers starting with the things we use all the time. Swiveling casters on all the racks, tool boxes and the tower of power would be nice. A work day could be scheduled for this fall. Trailer decal: Joe Stoesser will look into pricing and sizing of a TGRS decal on the small trailer. It would be app. 24-36 inches.
